## 1920. No. 93

REGULATIONS UNDER THE WAR PRECAUTIONS ACT 1914-1918 AND THE LAND, MINING, SHARES AND SHIPPING ACT 1919.

I THE GOVERNON-GENERAL in and over the Commonwealth of Australia, acting with the advice of the Federal Executive Council, hereby make the following Regulations under the War Prevalutions 1.el 1014-1018 and the Land, Mining, Shares and Shipping 1.et 1910, to come into expension forthwith.

Amendment of War Priecautions (Land Transfer) Regulations 1916,

- (Statutery Rules 1916, No. 35, as amonded by Statutory Rules 1916, Nos. 169, 189, and 326, Statutory Rules 1918, Nos. 44 and 76, and Statutory Rules 1919, No. 250.)
- Sub-regulation (2) of regulation 2 of the War Precautions (Land Transfer) Regulations is amouded by omitting the words "and a Christian".
- 2. After regulation 2A of the War Precautions (Land Transfer) Regulations, the following regulation is added to these Regulations:-
  - "2n. For the purposes of these Regulations, a woman who is whow of the widow of an enemy subject and who prior to marriage was comparable and antural-born British subject, shall be deemed to be n naturalized material bent person of enemy origin."
- Regulation 4cc of the War Preenutious (Land Transfer) Regulations is amended by inserting in sub-regulation (1) thereof after the word "shall" the words "without the consent in writing of the Public Trustee."
- Regulation 7 of the War Preeautions (Land Transfer) Regulations is repealed and the following regulation inserted in its stead:—
  - 1. (1) An application for consent under the provisions of Applications for regulations 4, 4A, 4AA, 4C or 4CC of these Regulations shall be made Mainter of in writing to the Attorney-General, or the Public Trustee, as Public Trustee. Authorises the Attorney-General of the Public Trustee. Authorises the Attorney-General of the name, address, date and place

of birth, parentage and occupation of the person making the application, and setting out the area, situation and value of the land, and full particulars of the proposed contract, agreement, nortragage, encumbrance, and the grounds upon which the application for the consent of the Attorney-General or the Public Trustee, as the case may be it based.

- "(2) The Attornoy-General or the Public Trustee, as the case may be, may, after making such further inquiry (if any) as he thinks fit, in his absolute discretion, grant or refuse consent to the application."
- 5. After regulation 8 of the War Precautions (Land Transfer) Regulations, the following regulation is added to these Regulations:-
  - "P. The Registrar of Titles or other proper efficer of any State may, upon submission to him, for registration in accordance with the laws of the State, of any instrument relating to a transaction in connexion with any land, require such evidence as he deems necessary that the transaction to which the instrument relates is not in contravention of any provision of these Regulations, and may refuse to register the instrument until such evidence is submitted to him."
