AMENDMENTS OF THE ALIENS REGULATIONS.†

- 1. Regulation 5 of the Aliens Regulations is amended by omitting Timeformaking from sub-regulation (2.) the word "sub-section" (first occurring) registration. and inserting in its stead the word "sub-regulation".
- 2. Regulation 9 of the Aliens Regulations is amended by omitting sub-regulation (4.) and inserting in its stead the following sub-regulation.

 Notification of change of address or occupation. tion :-

- "(4.) A notification by an alien, being a notification referred to in the preceding provisions of this regulation, shall be in writing in accordance with so much of Form 5 as is applicable in the circumstances of the case and shall be forwarded-
 - (a) where the place of residence of the alien is in a State or the Northern Territory—to the Commonwealth Migration Officer in the State or the Northern Territory, as the case may be; or
 - (b) where the place of residence of the alien is in the Australian Capital Territory—to the Secretary to the Department of Immigration.".
