## An Act relating to the Asian Development Bank

#### 1 Short title

This Act may be cited as the Asian Development Bank Act 1966.

#### 2 Commencement

This Act shall come into operation on the day on which it receives the Royal Assent.

#### 3 Definitions

In this Act:

**Bank** means the Asian Development Bank.

**Bank Agreement** means the Agreement establishing the Asian Development Bank, done at Manila on 4 December 1965, as in force for Australia from time to time.

The Agreement establishing the Asian Development Bank is in Australian Treaty Series 1966 No. 13 ([1966] ATS 13) and could in 2024 be viewed in the Australian Treaties Library on the AustLII website (http://www.austlii.edu.au).

## 4 Appropriation

There may be paid out of the Consolidated Revenue Fund, which is appropriated accordingly, any moneys necessary for the purpose of:

- (a) making any payment that Australia is required to make to the Bank in accordance with the Bank Agreement; or
- (b) redeeming a security issued under the next succeeding section.

### 5 Issue of securities

(1) To the extent to which the Bank is prepared to accept from Australia, in lieu of any payment that Australia is required to make

to the Bank, promissory notes or other obligations issued by Australia, the Governor-General may authorize the issue of securities.

- (2) Securities issued under the last preceding subsection:
  - (a) shall be payable to the Bank;
  - (b) shall be non-negotiable and non-interest bearing; and
  - (c) shall be payable at their par value on demand.

### Legislation history and amendment history—Endnotes 3 and 4

Amending laws are annotated in the legislation history and amendment history.

The legislation history in endnote 3 provides information about each law that has amended (or will amend) the compiled law. The information includes commencement details for amending laws and details of any application, saving or transitional provisions that are not included in this compilation.

The amendment history in endnote 4 provides information about amendments at the provision (generally section or equivalent) level. It also includes information about any provision of the compiled law that has been repealed in accordance with a provision of the law.

#### **Editorial changes**

The *Legislation Act 2003* authorises First Parliamentary Counsel to make editorial and presentational changes to a compiled law in preparing a compilation of the law for registration. The changes must not change the effect of the law. Editorial changes take effect from the compilation registration date.

If the compilation includes editorial changes, the endnotes include a brief outline of the changes in general terms. Full details of any changes can be obtained from the Office of Parliamentary Counsel.

#### Misdescribed amendments

A misdescribed amendment is an amendment that does not accurately describe how an amendment is to be made. If, despite the misdescription, the amendment

can be given effect as intended, then the misdescribed amendment can be incorporated through an editorial change made under section 15V of the *Legislation Act 2003*.

If a misdescribed amendment cannot be given effect as intended, the amendment is not incorporated and "(md not incorp)" is added to the amendment history.
