

Customs Tariff (No. 3)

No. 68 of 1967

An Act relating to Duties of Customs.

[Assented to 31 October 1967]

BE it enacted by the Queen's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

1.—(1.) This Act may be cited as the *Customs Tariff (No. 3) 1967*.

Short title
and citation.

(2.) The *Customs Tariffs 1966*,* as amended by the *Customs Tariff 1967*† and by the *Customs Tariff (No. 2) 1967*,‡ is in this Act referred to as the Principal Act.

(3.) Section 1 of the *Customs Tariff (No. 2) 1967* is amended by omitting sub-section (4.).

(4.) The Principal Act, as amended by this Act, may be cited as the *Customs Tariff 1966–1967*.

2.—(1.) Subject to this section, this Act shall come into operation on the day on which it receives the Royal Assent.
