## AMENDMENTS OF THE JURY EXEMPTION REGULATIONS?

- 1. Regulation 3 of the Jury Exemption Regulations is amended-
  - (a) by omitting from paragraph (p) of sub-regulation (2.) the word " and "; and
  - (b) by adding at the end of sub-regulation (2.) the following paragraphs:-
    - "(r) the Commissioner for Employees' Compensation; and
      - (s) a person constituting a Commonwealth Employees' Compensation Tribunal.".
