Naval Defence Amendment Act 1979

No. 133 of 1979

An Act to amend the Naval Defence Act 1910.

BE IT ENACTED by the Queen, and the Senate and House of Representatives of the Commonwealth of Australia, as follows:

Short title. **1.** (1) This Act may be cited as the Naval Defence Amendment Act &c. 1979.1

> (2) The Naval Defence Act 1910^2 is in this Act referred to as the **Principal Act.**

2. (1) Subject to sub-section (2), this Act shall come into operation Commencement on the day on which it receives the Royal Assent.¹

> (2) Sections 4 and 7 shall come into operation on the day on which sub-section 6(1) of the Defence Amendment Act 1979 comes into operation.

Application of Defence 3. Section 5 of the Principal Act is amended by adding at the end thereof the following sub-sections:

"(2) Subject to this Act, Part IIIA of the Defence Act applies to and in relation to the Navy and the members of the Navy.

"(3) In sub-section (2), a reference to this Act does not include a reference to the regulations.".

4. Section 38 of the Naval Defence Act 1910 is amended by omitting Establishment and from sub-section (7) all the words after "particular," and substituting constitution "for and in relation to the periods and conditions of service of members, of Naval other than conditions of service with respect to which determinations under section 58B of the Defence Act may be made.".

7. Notwithstanding the amendment made by section 4, the regu-Saving lations that were in force under the Naval Defence Act 1910 immediately before the date (in this section referred to as the "relevant date") of commencement of this section (including any such regulations as amended by determinations made under section 12 of the Defence Amendment Act 1979) and any determinations, directions or approvals that were in force under those regulations immediately before the relevant date shall, to the extent that they are not inconsistent with the Naval Defence Act 1910 as in force on the relevant date, continue in force on and after the relevant date as if those regulations had been made under the last-mentioned Act as so in force.
