- (b) by omitting clause 4 of Part 1AAA and substituting the following clause:
 - "4. Insert after subsection 63M (1) the following subsection:
 - '(1A) The report shall:
 - (a) set out any direction given, under subsection 6 (3) of the A.C.T. Institute of Technical and Further Education Ordinance 1987 of the Australian Capital Territory, by the appropriate Minister to the authority during the year to which the report relates; and
 - (b) specify the number of approvals (if any) given by the appropriate Minister under each of subsections 8 (1), 9 (1) and 10 (1) of that Ordinance in respect of which the appropriate Minister has not caused a copy of a statement to be laid before each House of Parliament.";
- (c) by inserting after Part 1AAA the following Part:
