Postal Services Regulations² (Amendment)

1. The Postal Services Regulations are amended by adding after regulation 55 the following regulation:

Allowances included in “salary” as defined in sub-section 46A (12) of the Act

“56. The allowances set out in the Schedule are declared to be included in salary for the purposes of the definition of “salary” in sub-section 46A (12) of the Act.”.
