Part 1—Preliminary

1 Short title

This Act may be cited as the Carbon Credits (Carbon Farming Initiative) Act 2011.

2 Commencement

(1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

3 Objects

2

(1) This section sets out the objects of this Act.

Carbon Credits (Carbon Farming Initiative) Act 2011

Climate Change Convention and Kyoto Protocol etc.

- (2) The first object of this Act is to remove greenhouse gases from the atmosphere, and avoid emissions of greenhouse gases, in order to meet Australia's obligations under any or all of the following:
 - (a) the Climate Change Convention;
 - (b) the Kyoto Protocol;
 - (c) an international agreement (if any) that is the successor (whether immediate or otherwise) to the Kyoto Protocol.

Incentives

(3) The second object of this Act is to create incentives for people to carry on certain offsets projects.

Carbon abatement

- (4) The third object of this Act is to increase carbon abatement in a manner that:
 - (a) is consistent with the protection of Australia's natural environment; and
 - (b) improves resilience to the effects of climate change.

Purchase of carbon abatement by the Commonwealth

(5) The fourth object of this Act is to authorise the purchase by the Commonwealth of units that represent carbon abatement.

4 Simplified outline

The following is a simplified outline of this Act:

- This Act sets up a scheme for the issue of Australian carbon credit units in relation to eligible offsets projects.
- Australian carbon credit units and certain other types of units may be purchased by the Commonwealth.

- This Act is administered by the Clean Energy Regulator.

- (b) the *Acts Interpretation Act 1901* to a *vacancy* in the membership of a body;

there are taken to be 4 offices of member of the Emissions Reduction Assurance Committee in addition to the Chair of the Emissions Reduction Assurance Committee.

7 Electronic notice transmitted to the Regulator

- (1) For the purposes of this Act, a notice is an *electronic notice transmitted to the Regulator* if, and only if:
 - (a) the notice is transmitted to the Regulator by means of an electronic communication; and

 - (f) the applicant is not subject to a requirement under Part 7 to relinquish a number of Australian carbon credit units; and

- (h) if the regulations or the legislative rules specify one or more other eligibility requirements—those requirements are met; the Regulator must issue a certificate of entitlement in respect of the project for the period.

Division 2—Carbon abatement contracts

20B Carbon abatement contracts

- (1) The functions of the Regulator include entering into contracts, on behalf of the Commonwealth, for the purchase by the Commonwealth of eligible carbon credit units.
- (2) It is immaterial whether the units are in existence when the contract is entered into.
- (3) For the purposes of this Act, a contract entered into under subsection (1) is to be known as a *carbon abatement contract*.
- (4) For the purposes of this Act, if the Regulator enters into a carbon abatement contract with a person, the person is a *carbon abatement contractor*.

20C When carbon abatement contracts may be entered into

- (1) The Regulator may enter into a carbon abatement contract under section 20B as the result of a carbon abatement purchasing process conducted by the Regulator under section 20G.

20F Carbon abatement purchasing process

- (e) encourage competition; and
- (f) provide for fair and ethical treatment of all participants in the process.
- (4) To avoid doubt, the mere fact that a person is a project proponent for an eligible offsets project does not automatically entitle the person to participate in a carbon abatement purchasing process.

Division 4—Miscellaneous

20H Legislative rules may provide for certain matters relating to purchased eligible carbon credit units etc.

- (1) The legislative rules may make provision for and in relation to any or all of the following matters in respect of eligible carbon credit units purchased by the Commonwealth under carbon abatement contracts:
 - (a) transferring purchased units to a specified Commonwealth Registry account;
 - (b) prohibiting or restricting the transfer of units from such an account;
 - (c) cancelling units for which there are entries in such an account.

Restoration of units that were transferred by mistake

- (f) the Regulator must make an entry for a restored unit in a Registry account kept by the person.

 - (g) if the project is a sequestration offsets project—include either:
 - (i) a request that the project be treated as a 100-year permanence period project; or
 - (ii) a request that the project be treated as a 25-year permanence period project; and
 - (ga) if:
 - (i) the project is an area-based offsets project; and
 - (ii) the project area, or any of the project areas, for the project is covered by a regional natural resource management plan;

- (6) Regulations or legislative rules made for the purposes of subsection (2) may empower the Regulator to determine that, whenever it is necessary to work out the net total number of Australian carbon credit units issued in relation to the transferee offsets project, this Act has effect, in relation to the transferee offsets project, as if the net total number of Australian carbon

(7) Subsections (3) to (6) do not limit subsection (2).

 - (iii) prescribed by the legislative rules; and
 - (iv) prepared by a registered greenhouse and energy auditor who has been appointed as an audit team leader for the purpose; and
- (cb) if, before the offsets report was given to the Regulator, the Regulator gave the project proponent a written notice stating that the offsets report would be subject to audit under this Act—be accompanied by an audit report that is:
 - (i) prescribed by the legislative rules; and
 - (ii) prepared by a registered greenhouse and energy auditor who has been appointed as an audit team leader for the purpose; and
- (cc) if a notice under section 77A is relevant to the offsets report—be accompanied by a copy of that notice; and
- (d) be accompanied by such other documents (if any) as are specified in the regulations or the legislative rules; and
- (e) be given to the Regulator within:
 - (i) 6 months after the end of the reporting period; or
 - (ii) if a greater number of months is specified in the applicable methodology determination for the project that greater number of months after the end of the reporting period.
- (5) The Regulator must not give a notice under paragraph (4)(cb) unless the Regulator is satisfied that it is appropriate to do so, having regard to effective risk management.

- (6) To avoid doubt, an offsets report for a period may deal with matters that occur before the start of that period.

 - (a) the relevant section 27 declarations were made as a result of applications covered by a particular subsection 26(2) determination;
 - (b) a particular person is the project proponent for the projects; offsets reports relating to those projects may be set out in the same document.
- (9) Information specified in regulations or legislative rules made for the purposes of paragraph (4)(b) may relate to a matter arising before, during or after the reporting period.
- (10) A document specified in regulations or legislative rules made for the purposes of paragraph (4)(d) may relate to a matter arising before, during or after the reporting period.

Ancillary contraventions

- (11) A person must not:
 - (a) aid, abet, counsel or procure a contravention of subsection (1); or
 - (b) induce, whether by threats or promises or otherwise, a contravention of subsection (1); or
 - (c) be in any way, directly or indirectly, knowingly concerned in, or party to, a contravention of subsection (1); or
 - (d) conspire with others to effect a contravention of subsection (1).

 - (f) the fee (if any) that must accompany such an application;
 - (g) the withdrawal of such an application;

 - (ii) is of the same duration as the permanence period for the project.

Declaration is not a legislative instrument

(15) A declaration made under subsection (2) is not a legislative instrument.

 - (b) each person who holds an eligible interest in the area, or any of the areas, of land; and
 - (c) a person specified in the regulations or the legislative rules; and
 - (d) the relevant land registration official.

(7) A failure to comply with subsection (6) does not affect the validity of a variation or revocation.

Refusal

(8) If the Regulator decides to refuse to vary or revoke the declaration, the Regulator must give written notice of the decision to the applicant.

Variation or revocation is not a legislative instrument

(9) A variation or revocation of the declaration is not a legislative instrument.

99 Revocation of declaration of carbon maintenance obligation—voluntary relinquishment of Australian carbon credit units

Scope

- (1) This section applies if:
 - (a) an area or areas of land are subject to a carbon maintenance obligation; and
 - (b) in the case of a single area—the area is not, and is not part of, a project area for an eligible offsets project that is a sequestration offsets project; and
 - (c) in the case of 2 or more areas—none of the areas is, or is part of, a project area for an eligible offsets project that is a sequestration offsets project; and
 - (d) a person applies to the Regulator for the revocation of the relevant subsection 97(2) declaration; and
 - (e) before the application was made, the applicant or another person voluntarily relinquished a number of Australian carbon credit units in order to satisfy a condition for revocation of the declaration; and
 - (f) the number of relinquished units equals the net total number of Australian carbon credit units issued in relation to the project in accordance with Part 2.

Application

 - (a) be in writing; and

- (4) If the Regulator revokes the declaration, the Regulator must take all reasonable steps to ensure that a copy of the revocation is given to:
 - (a) the project proponent for the project; and
 - (b) each person who holds an eligible interest in the area, or any of the areas, of land; and
 - (c) a person specified in the regulations or the legislative rules; and
 - (d) the relevant land registration official.
- (5) A failure to comply with subsection (4) does not affect the validity of a variation or revocation.

Refusal

(6) If the Regulator decides to refuse to revoke the declaration, the Regulator must give written notice of the decision to the applicant.

Revocation is not a legislative instrument

(7) A revocation of the declaration is not a legislative instrument.

100 Injunctions

Performance injunctions

- (1) If:
 - (a) a person has refused or failed, or is refusing or failing, or is proposing to refuse or fail, to do an act or thing; and

the Federal Court may, on the application of the Regulator, grant an injunction requiring the person to do that act or thing.

Restraining injunctions

 - (a) restraining the person from engaging in the conduct; and
 - (b) if, in the Court's opinion, it is desirable to do so—requiring the person to do something.

101 Interim injunctions

138

Grant of interim injunction

(1) If an application is made to the Federal Court for an injunction under section 100, the Court may, before considering the application, grant an interim injunction restraining a person from engaging in conduct of a kind referred to in that section.

No undertakings as to damages

(2) The Federal Court is not to require the Regulator, as a condition of granting an interim injunction, to give any undertakings as to damages.

102 Discharge etc. of injunctions

The Federal Court may discharge or vary an injunction granted under this Division.

103 Certain limits on granting injunctions not to apply

Performance injunctions

- (1) The power of the Federal Court to grant an injunction requiring a person to do an act or thing may be exercised:
 - (a) if the Court is satisfied that the person has refused or failed to do that act or thing—whether or not it appears to the Court that the person intends to refuse or fail again, or to continue to refuse or fail, to do that act or thing; or
 - (b) if it appears to the Court that, if an injunction is not granted, it is likely that the person will refuse or fail to do that act or thing—whether or not the person has previously refused or failed to do that act or thing.

Restraining injunctions

- (2) The power of the Federal Court under this Division to grant an injunction restraining a person from engaging in conduct of a particular kind may be exercised:
 - (a) if the Court is satisfied that the person has engaged in conduct of that kind—whether or not it appears to the Court that the person intends to engage again, or to continue to engage, in conduct of that kind; or
 - (b) if it appears to the Court that, if an injunction is not granted, it is likely that the person will engage in conduct of that

Division 1—Introduction

105 Simplified outline

The following is a simplified outline of this Part:

- The Minister may make or vary a methodology determination that applies to a specified kind of offsets project.
 - Before making or varying a methodology determination, the Minister must request the Emissions Reduction Assurance Committee to advise on the proposed determination or variation.
- In making or varying a methodology determination, the Minister must have regard to:
 - (a) advice given by the Emissions Reduction Assurance Committee; and
 - (b) the offsets integrity standards; and
 - (c) certain other matters.

Division 2—Methodology determinations

Subdivision A—Making of methodology determinations

106 Methodology determinations

- (1) The Minister may, by legislative instrument, make a determination that:
 - (a) is expressed to apply to a specified kind of offsets project; and
 - (b) sets out requirements that must be met for such a project to be an eligible offsets project; and
 - (c) provides that, if such a project is an eligible offsets project, the carbon dioxide equivalent net abatement amount for the project in relation to a reporting period for the project is taken, for the purposes of this Act, to be equal to the amount ascertained using a method specified in, or ascertained in accordance with, the determination.
 - Note 1: For declarations of eligible offsets projects, see section 27.
 - Note 2: See also subsection 27(4A) in relation to certain additionality requirements that may be specified in a methodology determination.
 - Note 3: See also sections 69, 70 and 71 in relation to specifying a crediting period in a methodology determination.
 - Note 4: See also paragraph 76(4)(e) in relation to specifying in a methodology determination the deadline for giving an offsets report.
 - Note 5: See also subsection 77A(2) in relation to setting out in a methodology determination requirements relating to the division of an offsets project into 2 or more parts.
- (2) A determination under subsection (1) is to be known as a *methodology determination*.
- (3) A methodology determination that applies to a particular kind of offsets project may provide that, if such a project is an eligible offsets project, the project proponent for the project is subject to any or all of the following requirements:

- (a) specified requirements to include specified information relating to the project in each offsets report about the project;
- (b) specified requirements to notify one or more matters relating to the project to the Regulator;
- (c) specified record-keeping requirements relating to the project;

- (4) In deciding whether to make a methodology determination, the Minister must have regard to the following:
 - (a) whether the determination complies with the offsets integrity standards:
 - (b) any advice that the Emissions Reduction Assurance Committee has given to the Minister under subsection 123A(2) in relation to the making of the determination;
 - (c) whether any adverse environmental, economic or social impacts are likely to arise from the carrying out of the kind of project to which the determination applies;
 - (d) such other matters (if any) as the Minister considers relevant.
- (4A) The Minister must not make a methodology determination unless a method specified in, or ascertained in accordance with, the determination in accordance with paragraph (1)(c) provides that carbon abatement used in ascertaining the carbon dioxide equivalent net abatement amount for a project is eligible carbon abatement from the project.
- (4B) The Minister must not make a methodology determination if the Emissions Reduction Assurance Committee has advised the Minister under subsection 123A(2) that the determination does not comply with one or more of the offsets integrity standards.
 - (7) Paragraph (1)(a) of this section does not, by implication, affect the application of subsection 13(3) of the *Legislation Act 2003* to another instrument under this Act.

- (8) A methodology determination may make provision in relation to a matter by applying, adopting or incorporating, with or without modification, a matter contained in an instrument or writing:
 - (a) as in force or existing at a particular time; or

- (9A) A methodology determination may make provision in relation to a matter by conferring a power to make a decision of an administrative character on the Regulator.

- (10) Before making a methodology determination, the Minister must request the Emissions Reduction Assurance Committee to advise the Minister about whether the Minister should make the determination.

Note: The Emissions Reduction Assurance Committee must have regard to certain matters in giving advice to the Minister (see section 123A).

- (11) If the Minister decides:
 - (a) to make a methodology determination; or
 - (b) not to make a methodology determination;

the Minister must:

- (c) cause a copy of any advice given by the Emissions Reduction Assurance Committee under subsection 123A(2) in relation to the determination to be published on the Department's website; and
- (d) do so as soon as practicable after making the decision.

Subdivision B—Variation of methodology determinations

114 Variation of methodology determinations

(1) The Minister may, by legislative instrument, vary a methodology determination.

 - (5) Subsection (1) of this section does not, by implication, limit the application of subsection 33(3) of the *Acts Interpretation Act 1901* to other instruments under this Act.
 - Advice given by the Emissions Reduction Assurance Committee
 - (6) Before varying a methodology determination, the Minister must request the Emissions Reduction Assurance Committee to advise the Minister about whether the Minister should vary the determination.
 - Note 1: The Emissions Reduction Assurance Committee must have regard to certain matters in giving advice to the Minister (see section 123A).
 - Note 2: For variations of a minor nature, see subsection (9).
 - (7) In deciding whether to vary a methodology determination, the Minister must have regard to the following:
 - (a) any relevant advice given by the Emissions Reduction Assurance Committee under subsection 123A(2);

- (b) such other matters (if any) as the Minister considers relevant.
- (7A) The Minister must not vary a methodology determination so as to extend the crediting periods for the eligible offsets projects covered by the determination unless:
 - (a) the Emissions Reduction Assurance Committee has advised the Minister under subsection 123A(2) or paragraph 255(hc) that the variation should be made; and
 - (b) the Emissions Reduction Assurance Committee has not previously advised the Minister under subsection 123A(2) or paragraph 255(hc) that the variation should not be made; and
 - (c) the determination has not previously been varied so as to extend the crediting periods.
- (7B) The Minister must not vary a methodology determination if the Emissions Reduction Assurance Committee has advised the Minister under subsection 123A(2) that the varied determination does not comply with one or more of the offsets integrity standards.
 - (8) If the Minister decides:
 - (a) to vary a methodology determination; or
 - (b) not to vary a methodology determination;

the Minister must:

- (c) cause a copy of any advice given by the Emissions Reduction Assurance Committee under subsection 123A(2) in relation to the determination to be published on the Department's website; and
- (d) do so as soon as practicable after making the decision.
- (9) Subsections (6), (7), (7B) and (8) do not apply to a variation if the variation is of a minor nature.

A variation of a methodology determination takes effect:

(a) on the day on which the instrument varying the methodology determination is made; or

Subdivision C—Duration of methodology determinations

122 Duration of methodology determinations

Subdivision DA—Advice about making, varying or revoking methodology determinations

123A Advice by the Emissions Reduction Assurance Committee

 - (a) under subsection 106(10), to give advice about whether the Minister should make a methodology determination; or
 - (b) under subsection 114(6), to give advice about whether the Minister should vary a methodology determination; or

Committee must have regard to certain matters

- (5) In giving the requested advice to the Minister, the Emissions Reduction Assurance Committee must have regard to the following:
 - (a) the offsets integrity standards;
 - (b) any relevant matters specified in a direction in force under section 123B;
 - (c) any relevant advice given by the Regulator to the Committee.
- (6) Subsection (5) does not, by implication, limit the matters to which the Emissions Reduction Assurance Committee may have regard.

123B Additional matters for the Emissions Reduction Assurance Committee to take into account

The Minister may, by legislative instrument, direct the Emissions Reduction Assurance Committee to do any or all of the following:

- (b) the member advises the Committee that:
 - (i) if the Minister were to make a proposed methodology determination, the determination would not comply with the offsets integrity standard set out in paragraph 133(1)(c); or
 - (ii) if the Minister were to make a particular variation of a methodology determination, the varied determination would not comply with the offsets integrity standard set out in paragraph 133(1)(c);

then, in giving relevant advice to the Minister under subsection 123A(2), the Emissions Reduction Assurance Committee is to assume that the determination or varied determination, as the case may be, would not comply with that offsets integrity standard.

Note:

Paragraph 133(1)(c) is about ensuring that the method in a methodology determination relates to eligible carbon abatement.

Subdivision DB—Consultation by the Emissions Reduction Assurance Committee

123D Consultation by the Emissions Reduction Assurance Committee

- (1) The Emissions Reduction Assurance Committee must not advise the Minister to make or vary a methodology determination unless the Committee has first:
 - (a) published on the Department's website:
 - (i) a detailed outline of the proposed determination or variation, as the case may be; and
 - (ii) a notice inviting the public to make a submission to the Committee on the detailed outline by a specified time limit; and
 - (b) considered any submissions that were received within that time limit.
- (2) The time limit must be 28 days after the notice is published.
- (3) However, the time limit may be shorter than 28 days after the notice is published, so long as:

 - (a) the application of another methodology determination to the project, with effect from a particular time; or
 - (b) the application of the original determination as varied to the project, with effect from a particular time;

subsection (2) does not apply to the project during so much of the crediting period as occurs after that time.

 - (b) give a copy of the annotated declaration to the project proponent for the project.

Refusal

(5) If the Regulator decides to refuse to approve the application of the methodology determination to the project, the Regulator must give written notice of the decision to the person who made the request.

Approval is not a legislative instrument

(6) An approval given under subsection (2) is not a legislative instrument.

the removal, reduction or emission, as the case may be, should be:

- (iv) measurable; and
- (v) capable of being verified;
- (c) a method specified in, or ascertained in accordance with, a methodology determination in accordance with paragraph 106(1)(c) should provide that carbon abatement used in ascertaining the carbon dioxide equivalent net abatement amount for a project must be eligible carbon abatement from the project;

- (4) The Minister may, by legislative instrument, make a determination providing that a specified estimate, projection or assumption is taken to be conservative for the purposes of this section.

- (3) The multiple project proponents are not entitled to take an eligible voluntary action except in accordance with subsection (2).

139 Unilateral revocation of declaration of eligible offsets project—failure of multiple project proponents to nominate a nominee

- (1) The regulations or the legislative rules may make provision for and in relation to empowering the Regulator to revoke a declaration under section 27 in relation to an offsets project.

147 Issue of Australian carbon credit units

The Regulator may, on behalf of the Commonwealth, issue units, to be known as Australian carbon credit units.

148 How Australian carbon credit units are to be issued

- (1) The Regulator is to issue an Australian carbon credit unit to a person by making an entry for the unit in a Registry account kept by the person.
- (2) The Regulator must not issue an Australian carbon credit unit to a person unless the person has a Registry account.

149 Circumstances in which Australian carbon credit units may be issued

The Regulator must not issue an Australian carbon credit unit otherwise than in accordance with Part 2.

Division 3—Property in, and transfer of, Australian carbon credit units

150 An Australian carbon credit unit is personal property

An Australian carbon credit unit is personal property and, subject to sections 152 and 153, is transmissible by assignment, by will and by devolution by operation of law.

150A Ownership of Australian carbon credit unit

- (1) The registered holder of an Australian carbon credit unit:
 - (a) is the legal owner of the unit; and
 - (b) may, subject to this Act and the *Australian National Registry* of *Emissions Units Act 2011*, deal with the unit as its legal owner and give good discharges for any consideration for any such dealing.
- (2) Subsection (1) only protects a person who deals with the registered holder of the unit as a purchaser:
 - (a) in good faith for value; and
 - (b) without notice of any defect in the title of the registered holder.

151 Transfer of Australian carbon credit units

For the purposes of this Act, if there is an entry for an Australian carbon credit unit in a Registry account (the *first Registry account*) kept by a person (the *first person*):

- (a) a *transfer* of the unit from the first Registry account to a Registry account kept by another person consists of:
 - (i) the removal of the entry for the unit from the first Registry account; and
 - (ii) the making of an entry for the unit in the Registry account kept by the other person; and

- (5) If the transferor is the Commonwealth, the Minister may give an instruction under subsection (1) on behalf of the transferor.

184 Simplified outline

The following is a simplified outline of this Part:

• The Regulator may obtain information or documents.

185 Regulator may obtain information or documents

Scope

(1) This section applies to a person if the Regulator believes on reasonable grounds that the person has information or a document that is relevant to the operation of this Act or the associated provisions.

Requirement

- (2) The Regulator may, by written notice given to the person, require the person:
 - (a) to give to the Regulator, within the period and in the manner and form specified in the notice, any such information; or
 - (b) to produce to the Regulator, within the period and in the manner specified in the notice, any such documents; or
 - (c) to make copies of any such documents and to produce to the Regulator, within the period and in the manner specified in the notice, those copies.
- (3) A period specified under subsection (2) must not be shorter than 14 days after the notice is given.

Compliance

(4) A person must comply with a requirement under subsection (2) to the extent that the person is capable of doing so.

Ancillary contraventions

- (5) A person must not:
 - (a) aid, abet, counsel or procure a contravention of subsection (4); or

 - (b) arrange for the audit team leader to carry out an audit on one or more aspects of the person's compliance with this Act or the associated provisions; and
 - (c) arrange for the audit team leader to give the person a written report setting out the results of the audit; and
 - (d) give the Regulator a copy of the audit report on or before the day specified in the notice.

Note: For the conduct of an audit under this section, see section 75 of the *National Greenhouse and Energy Reporting Act 2007*.

(3) The notice must specify:

- (d) the officer failed to take all reasonable steps to prevent the contravention;

the officer contravenes this subsection.

- (2) For the purposes of subsection (1), the officer is *reckless* as to whether the contravention would occur if:
 - (a) the officer is aware of a substantial risk that the contravention would occur; and
 - (b) having regard to the circumstances known to the officer, it is unjustifiable to take the risk.

- (4) The pecuniary penalty payable under subsection (1) by a body corporate must not exceed 10,000 penalty units for each contravention.
- (5) The pecuniary penalty payable under subsection (1) by a person other than a body corporate must not exceed 2,000 penalty units for each contravention.
 - Civil enforcement of penalty
- (6) A pecuniary penalty is a civil debt payable to the Commonwealth. The Commonwealth may enforce the civil penalty order as if it were an order made in civil proceedings against the person to recover a debt due by the person. The debt arising from the order is taken to be a judgement debt.

- (5) An approved form of an application may provide for verification by statutory declaration of statements in applications.
- (6) A fee specified under paragraph (3)(c) must not be such as to amount to taxation.

242 Reconsideration by the Regulator

- (1) Upon receiving such an application, the Regulator must:
 - (a) reconsider the decision; and
 - (b) affirm, vary or revoke the decision.
- (2) The Regulator's decision on reconsideration of a decision has effect as if it had been made under the provision under which the original decision was made.

256 Membership of the Emissions Reduction Assurance Committee

The Emissions Reduction Assurance Committee consists of the following members:

- (a) a Chair;
- (b) at least 4, and not more than 8, other members.

257 Appointment of Emissions Reduction Assurance Committee members

(1) Each Emissions Reduction Assurance Committee member is to be appointed by the Minister by written instrument.

Note: An Emissions Reduction Assurance Committee member is eligible for reappointment: see the *Acts Interpretation Act 1901*.

- (2) A person is not eligible for appointment as an Emissions Reduction Assurance Committee member unless the Minister is satisfied that the person has:
 - (a) substantial experience or knowledge; and
 - (b) significant standing;

in at least one field of expertise that is relevant to the functions of the Emissions Reduction Assurance Committee.

- (3) The Minister must ensure that the Chair of the Emissions Reduction Assurance Committee is not a person covered by subsection (4).
- (4) This subsection applies to the following persons:
 - (a) an employee of the Commonwealth;
 - (b) an employee of an authority of the Commonwealth;
 - (c) a person who holds a full-time office under a law of the Commonwealth.

- (5) The Minister must ensure that one Emissions Reduction Assurance Committee member:
 - (a) is an SES employee in the Department; or

- (7) An Emissions Reduction Assurance Committee member holds office on a part-time basis.

258 Period for appointment for Emissions Reduction Assurance Committee members

An Emissions Reduction Assurance Committee member holds office for the period specified in the instrument of appointment. The period must not exceed 5 years.

259 Acting Emissions Reduction Assurance Committee members

 - (a) without meeting, a majority of Emissions Reduction Assurance Committee members indicate agreement with the resolution in accordance with the method determined by the Emissions Reduction Assurance Committee under subsection (3); and
 - (b) all Emissions Reduction Assurance Committee members were informed of the proposed resolution, or reasonable efforts had been made to inform all Emissions Reduction Assurance Committee members of the proposed resolution.
- (3) Subsection (2) applies only if the Emissions Reduction Assurance Committee:
 - (a) determines that it applies; and
 - (b) determines the method by which Emissions Reduction Assurance Committee members are to indicate agreement with resolutions.
- (4) If an Emissions Reduction Assurance Committee member is an APS employee in the Department, the member:
 - (a) is not entitled to vote for a resolution at a meeting of the Emissions Reduction Assurance Committee; and
 - (b) is not entitled to indicate agreement with a resolution as mentioned in paragraph (2)(a); and

- (c) is not to be counted for the purposes of determining whether a majority of Emissions Reduction Assurance Committee members:

261 Disclosure of interests to the Minister

An Emissions Reduction Assurance Committee member must give written notice to the Minister of all interests, pecuniary or otherwise, that the member has or acquires and that conflict or could conflict with the proper performance of the member's functions.

262 Disclosure of interests to Emissions Reduction Assurance Committee

- (1) An Emissions Reduction Assurance Committee member who has an interest, pecuniary or otherwise, in a matter being considered or about to be considered by the Emissions Reduction Assurance Committee must disclose the nature of the interest to a meeting of the Emissions Reduction Assurance Committee.

- (5) For the purposes of making a determination under subsection (4), the Emissions Reduction Assurance Committee member:

 - (b) must not take part in making the determination.
- (6) A determination under subsection (4) must be recorded in the minutes of the meeting of the Emissions Reduction Assurance Committee.

263 Outside employment

An Emissions Reduction Assurance Committee member must not engage in any paid employment that conflicts or may conflict with the proper performance of his or her duties.

264 Remuneration and allowances

- (1) An Emissions Reduction Assurance Committee member is to be paid the remuneration that is determined by the Remuneration Tribunal. If no determination of that remuneration by the Tribunal is in operation, the member is to be paid the remuneration that is prescribed.

- (3) This section has effect subject to the *Remuneration Tribunal Act* 1973.

265 Leave of absence

(1) The Minister may grant leave of absence to the Chair of the Emissions Reduction Assurance Committee on the terms and conditions that the Minister determines.

 - (ii) uses the information.

 - (b) to disclose protected information to a court or tribunal.

Secondary disclosure and use

- (4) A person commits an offence if:

 - (b) protected audit information has been disclosed under subsection (3) to the body corporate; and
 - (c) the person:
 - (i) discloses the information to another person; or
