No. 87, 2021 Tertiary Education Quality and Standards Agency (Charges) Amendment Act 2021 1

1 Short title

This Act is the *Tertiary Education Quality and Standards Agency* (Charges) Amendment Act 2021.

2 Commencement

(1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

1 Subsection 7(4)

Repeal the subsection, substitute:

(4) For the purposes of subsection (3), disregard any costs that are likely to be offset by fees determined by TEQSA under section 158 of the *Tertiary Education Quality and Standards Agency Act 2011*.
