# HEAVY VEHICLE NATIONAL LAW Queensland Class 2 Gympie Bypass Authorisation Notice 2024 (No.1)

#### 1. Purpose

1) This notice provides access to the Gympie Bypass for eligible vehicles that have a class 2 heavy vehicle authorisation (permit) under the Heavy Vehicle National Law (HVNL).

Note:

This notice does not apply to all class 2 vehicles, but only to those with a permit authorising it to operate on the section of the Old Bruce Highway that now corresponds with the Gympie Bypass.

### 2. Authorising Provision

- 1) This notice is made under the following sections of the Heavy Vehicle National Law (HVNL):
  - a) section 138 Regulator's power to authorise use of all or stated categories of class 2 heavy vehicles.

## 3. Title

This notice may be cited as the *Queensland Class 2 Gympie Bypass Authorisation Notice 2024 (No.1).* 

#### 4. Commencement

This notice commences on 6 November 2024.

# 5. Expiry

This notice expires on 5 November 2025.

#### 6. Definitions

- 1) Unless otherwise stated, words and expressions used in this notice have the same meanings as those in the HVNL and its regulations.
- 2) In this notice:

**Gympie Bypass** means the Bruce Highway between Cooroy and Curra from the Woondum interchange to the Curra interchange travelling east of the Gympie township.

**Old Bruce Hwy** means the previous Bruce Highway from the Curra interchange following the now Cooroy–Gympie Road from the Woondum interchange to Gympie and the now Gympie-Curra Road from Gympie to the Curra interchange.

#### 7. Application

- 1) This notice applies to a class 2 heavy vehicle that meets all the requirements in this section.
- 2) This notice applies to a heavy vehicle operating under a current class 2 permit issued before the 24 October 2024 under section 143 of the HVNL that contains as part of its network conditions a route that includes the Old Bruce Hwy.
- 3) This notice applies in Queensland.
- 4) A heavy vehicle to which this section applies and that complies with the conditions of this notice is an eligible vehicle.

# 8. Exemption from prescribed mass and dimension requirements

An eligible vehicle operating under this notice must comply with the mass and/or dimension requirements specified in the permit issued for the vehicle and referred to in section 7(2) of this notice.

## 9. Conditions: Routes

This notice applies to an eligible vehicle travelling under a permit in section 7(2) of this notice and operating on the Gympie Bypass.

## 10. Conditions: Gympie Bypass

- 1) An eligible vehicle operating under this notice and travelling under a permit in section 7(2) of this notice may travel on the Gympie Bypass.
- 2) When operating on the Gympie Bypass the eligible vehicle must comply with any condition:
  - a) specified in the permit issued for the vehicle and referred to in section 7(2) of this notice; and
  - b) that apply to the vehicle when operating on the Old Bruce Hwy.
