- (a) The *Corporations Law* was amended by sections 5-9, 17 and 18 only of the *Corporations Legislation Amendment Act 1991*, subsections 2(1), (4) and (10) of which provide as follows:
- (1) Subject to this section, this Act commences on the day on which it receives the Royal Assent.
 - (4) Subject to subsection (5), sections 7 and 8 commence on a day or days to be fixed by Proclamation.
 - (10) Subject to subsection (11), the provisions of Part 6 commence on a day or days to be fixed by Proclamation.
- (b) Subsection 2(2) of the *Corporations Legislation Amendment Act (No. 2) 1991* provides as follows:
- (2) Part 2 commences, or is taken to have commenced, as the case requires, immediately after the commencement of the amendment of the *Corporations Act 1989* referred to in paragraph 2(3)(d) of the *Corporations Legislation Amendment Act 1991*.
- (ba) The *Corporate Law Reform Act 1992* was amended by Schedule 5 only of the *Law and Justice Legislation Amendment Act 1999*, subsection 2(5) of which provides as follows:
- (5) Schedule 5 is taken to have commenced on 23 June 1993, immediately after the commencement of section 123 of the *Corporate Law Reform Act 1992*.
- (c) The *Corporations Law* was amended by sections 7-11 only of the *Banking (State Bank of South Australia and Other Matters) Act 1994*, subsection 2(1) of which provides as follows:
- (1) Subject to this section, this Act commences on the day on which it receives the Royal Assent.
- (d) The *Corporations Law* was amended by Schedule 6 of the *Corporations Legislation Amendment Act 1994*, subsection 2(2) of which provides as follows:
- (2) Schedule 6 commences immediately after all the other provisions of this Act, and all the provisions of the *Corporate Law Reform Act 1994*, have commenced.
- (e) The *Corporations Law* was amended by Schedule 2 (items 34-44) only of the *Statute Law Revision Act 1996*, subsection 2(2) of which provides as follows:
- (2) Each item in Schedule 2 commences or is taken to have commenced (as the case requires) at the time specified in the note at the end of the item.
- Item 34 is taken to have commenced immediately after the commencement of item 9 of Schedule 8 to the *Corporations Legislation Amendment Act 1994*.
- Item 9 of Schedule 8 commenced on 15 July 1994 (see *Gazette* 1994, No. GN27).
- Items 35, 36 and 38-40 are taken to have commenced immediately after the commencement of sections 205, 350, 599, 613 and 703, respectively, of the *Corporations Law*.
- Sections 205, 350, 599, 613 and 703 commenced on 1 January 1991 (see *Gazette* 1990, No. S335).
- Item 37 is taken to have commenced immediately after the commencement of section 7 of the *Corporations Legislation Amendment Act 1994*.
- Section 7 commenced on 1 August 1991 (see *Gazette* 1997, No. S208).
- Items 41-44 are taken to have commenced immediately after the commencement of Schedule 1 of the *Corporations Law*.
- Schedule 1 commenced on 1 January 1991 (see *Gazette* 1990, No. S335).

- (g) The Corporations Law was amended by Schedule 3 only of the *Financial Sector Reform (Consequential Amendments) Act 1998*, subsections 2(2) and (14) of which provides as follows:
- (2) Subject to subsections (3) to (14), Schedules 1, 2 and 3 commence on the commencement of the *Australian Prudential Regulations Authority Act 1998*.
 - (14) Items 4, 6, 12, 14, 15, 16 and 28 of Schedule 3 commence immediately after the commencement of the *Managed Investments Act 1998*.
- The *Managed Investments Act 1998* came into operation immediately after all the items in Schedules 1-4 of the *Company Law Review Act 1998* commenced.
Schedules 1-4 commenced on 1 July 1998 (see *Gazette* 1998, No. S317).

 - (b) immediately after the commencement of the *Managed Investments Act 1998* if that Act does not commence before the commencement of the *Australian Prudential Regulation Authority Act 1998*.
- Item 32 of Schedule 3 to the *Company Law Review Act 1998* commenced on 1 July 1998 (see *Gazette* 1998, No. S317)
Schedule 5 of the *Company Law Review Act 1998* commenced immediately after the commencement of section 1 of the *Taxation Laws Amendment (Company Law Review) Act 1998*.
Section 1 commenced on 1 July 1998 (see *Gazette* 1998, No. S325)

(k) Subsection 2(2) of the *Corporations Legislation Amendment Act 1998* provides as follows:

- (2) Section 3 and Schedule 1 commence, or are taken to have commenced, immediately after the commencement of item 11 of Schedule 1 to the *Company Law Review Act 1998*.

Item 11 of Schedule 1 commenced on 1 July 1998 (see *Gazette* 1998, No. S317)

(l) The Corporations Law was amended by Schedule 3 only of the *Financial Sector Reform (Amendments and Transitional Provisions) Act (No. 1) 1999*, subsections 3(1), (2)(b), (3) and (16) of which provide as follows:

- (1) Subject to this section, this Act commences on the day on which it receives the Royal Assent.
- (2) The following provisions commence on the transfer date:
 - (b) subject to subsections (3), (4) and (5), Schedule 3, other than items 1, 33, 34, 45, 46 and 63 (the commencement of those items is covered by subsection (1));
- (3) If item 1 of Schedule 3 commences before the commencement of Schedule 1 to the *Corporate Law Economic Reform Program Act 1999*, item 60 of Schedule 3 commences on the transfer date and item 61 of Schedule 3 commences immediately after the commencement of Schedule 1 to that Act.
- (16) The Governor-General may, by Proclamation published in the *Gazette*, specify the date that is to be the transfer date for the purposes of this Act.

The transfer date was 1 July 1999 (see *Gazette* 1999, No. S283)

Item 61 commenced on 13 March 2000 immediately after Schedule 1 to the *Corporate Law Economic Reform Program Act 1999* commenced (see *Gazette* 2000, No. S114).

(m) The Corporations Law was amended by Schedules 1, 3, 6, 8 and 11 only of the *Corporate Law Economic Reform Program Act 1999*, subsections 2(2), (4), (6) and (7) of which provide as follows:

- (2) The following provisions commence on a day or days to be fixed by Proclamation:
 - (a) section 3;
 - (b) the items in Schedules 1 to 7 (other than item 18 of Schedule 7);
 - (c) the items in Schedules 10, 11 and 12.
- (4) If an item in Schedule 11 or 12 does not commence under subsection (2) within the period of 12 months beginning on the day on which this Act receives the Royal Assent, it commences on the first day after the end of that period.
- (6) The items in Schedule 8 (other than item 3) are taken to have commenced immediately after the *Managed Investments Act 1998*.
- (7) Item 3 of Schedule 8 is taken to have commenced immediately after section 27 of the *Corporate Law Reform Act 1992*.

The *Managed Investments Act 1998* came into operation immediately after Schedules 1-4 of the *Company Law Review Act 1998*.

Schedules 1-4 commenced on 1 July 1998 (see *Gazette* 1998, No. S317).

Section 27 of the *Corporate Law Reform Act 1992* commenced on 1 February 1993 (see *Gazette* 1993, No. S25).

(n) The Corporations Law was amended by Schedule 4 only of the *A New Tax System (Tax Administration) Act (No. 2) 2000*, subsection 2(5) of which provides as follows:

- (5) Schedule 4 commences, or is taken to have commenced, on 1 July 2000.
