5 **1 Short title**

6 This Act may be cited as the *Tax Laws Amendment (2011*
7 *Measures No. 2) Act 2011*.

8 **2 Commencement**

9 (1) Each provision of this Act specified in column 1 of the table
10 commences, or is taken to have commenced, in accordance with
11 column 2 of the table. Any other statement in column 2 has effect
12 according to its terms.

16 (c) antiques; or

21 (h) memorabilia; or
22 (i) wine; or

24 (k) recreational boats; or
25 (l) memberships of sporting or social clubs; or

16 (2) An RSA provider may, subject to any conditions contained in the
17 regulations, use tax file numbers quoted as mentioned in
18 subsection (1) in order to locate, in the records or accounts of the
19 RSA provider, amounts held in RSAs provided by it.

20 Note: Sections 8WA and 8WB of the *Taxation Administration Act 1953*
21 contain offences for unauthorised use etc. of tax file numbers.

22 (3) This section does not affect the operation of subclauses 7.1 and
23 7.1A of National Privacy Principle 7 in Schedule 3 to the *Privacy*
24 *Act 1988*.

25 Note 1: Subclause 7.1 prohibits an RSA provider adopting a tax file number of
26 an individual as the RSA provider's own identifier of the individual,
27 such as by using the tax file number as an account or membership
28 number.

29 Note 2: See also Division 4 of Part III of the *Privacy Act 1988* and the
30 guidelines issued under that Division concerning the collection,
31 storage, use and security of tax file number information.

9 (2) A trustee of an eligible superannuation entity, or of a regulated
10 exempt public sector superannuation scheme, may, subject to any
11 conditions contained in the regulations, use tax file numbers quoted
12 as mentioned in subsection (1) in order to locate, in the records or
13 accounts of the entity or scheme, amounts held for the benefit of
14 persons.

15 Note: Sections 8WA and 8WB of the *Taxation Administration Act 1953*
16 contain offences for unauthorised use etc. of tax file numbers.

17 (3) This section does not affect the operation of subclauses 7.1 and
18 7.1A of National Privacy Principle 7 in Schedule 3 to the *Privacy*
19 *Act 1988*.

20 Note 1: Subclause 7.1 prohibits a trustee adopting a tax file number of an
21 individual as the trustee's own identifier of the individual, such as by
22 using the tax file number as an account or membership number.

23 Note 2: See also Division 4 of Part III of the *Privacy Act 1988* and the
24 guidelines issued under that Division concerning the collection,
25 storage, use and security of tax file number information.

26 **13 Application provision**

 - 19 (ii) interests of the person in eligible superannuation entities
20 or regulated exempt public sector superannuation
21 schemes.

16 **81-1 What this Division is about**

17 GST does not apply to payments of taxes, fees and charges that are
18 excluded from the GST by this Division or by regulations.

19 GST applies to certain taxes, fees and charges prescribed by
20 regulations.

21 **81-5 Effect of payment of tax**

22 *Australian tax not consideration*

- 23 (1) A payment, or the discharging of a liability to make a payment, is
24 not the provision of *consideration to the extent the payment is an
25 *Australian tax.

1 *Regulations may provide for exceptions*

2 (2) However, a payment you make, or a discharging of your liability to
3 make a payment, is treated as the provision of *consideration to the
4 extent the payment is an *Australian tax that is, or is of a kind,
5 prescribed by the regulations.

6 (3) For the purposes of subsection (2), the *consideration is taken to be
7 provided to the entity to which the tax is payable, for a supply that
8 the entity makes to you.

9 **81-10 Effect of payment of certain fees and charges**

10 *Certain fees and charges not consideration*

11 (1) A payment, or the discharging of a liability to make a payment, is
12 not the provision of *consideration to the extent the payment is an
13 *Australian fee or charge that is of a kind covered by subsection (4)
14 or (5).

15 *Prescribed fees and charges treated as consideration*

16 (2) However, a payment you make, or a discharging of your liability to
17 make a payment, is treated as the provision of *consideration to the
18 extent the payment is an *Australian fee or charge that is, or is of a
19 kind, prescribed by the regulations.

20 (3) For the purposes of subsection (2), the *consideration is taken to be
21 provided to the entity to which the fee or charge is payable, for a
