**A Bill for an Act to deal with consequential matters arising from the enactment of the *Emergency Response Fund Act 2019*, and for other purposes**

The Parliament of Australia enacts:

**1 Short title**

This Act is the *Emergency Response Fund (Consequential Amendments) Act 2019*.

**2 Commencement**

- (1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

## **Part 3—Transitional provisions**

### **43 Transitional—reporting obligations of the Future Fund Board of Guardians**

Despite the repeal of the *Nation-building Funds Act 2008* by this Schedule, sections 203 and 204 of that Act (which deal with reporting obligations) continue to apply, after the commencement of this item, in relation to:

- (a) the performance of the Future Fund Board of Guardians' functions; and
- (b) the operation of the Board;

in respect of the repealed Education Investment Fund, as if the repeal of those sections had not happened.

### **44 Transitional—reports**

Despite the amendments of section 81 of the *Future Fund Act 2006* made by this Schedule, that section continues to apply, in relation to the annual report for the period in which this item commences, as if those amendments had not been made.

### **45 Transitional rules**

- (1) The Minister may, by legislative instrument, make rules prescribing matters of a transitional nature (including prescribing any saving or application provisions) relating to the amendments or repeals made by this Schedule.
- (2) However, to avoid doubt, the rules may not do the following:
  - (a) create an offence or civil penalty;
  - (b) provide powers of:
    - (i) arrest or detention; or
    - (ii) entry, search or seizure;
  - (c) impose a tax;
  - (d) set an amount to be appropriated from the Consolidated Revenue Fund under an appropriation in this Act;
  - (e) directly amend the text of this Act.
