National Health (Pharmaceutical Benefits) Regulations² (Amendment)

I, THE GOVERNOR-GENERAL of the Commonwealth of Australia, acting with the advice of the Federal Executive Council, and pursuant to section 4 of the *Acts Interpretation Act 1901*, hereby make the following Regulations under the *National Health Act 1953*.

Principal Regulations

1. In these Regulations, "Principal Regulations" means the National Health (Pharmaceutical Benefits) Regulations.

2. After regulation 9B of the Principal Regulations the following regulation is inserted:

Prescribed offices for the purposes of subsection 84E (5) of the Act

"9BA. For the purposes of subsection 84E (5) of the Act, each office specified in Schedule 7 is a prescribed office."

3. The Principal Regulations are amended by adding at the end the following Schedule:
