1 Name of Regulations

These Regulations are the *Financial Management and Accountability Amendment Regulations 2008 (No. 1)*.

2 Commencement

These Regulations commence as follows:

- (a) on the day after they are registered — regulations 1 to 3 and Schedule 1;
- (b) immediately after the commencement of section 171 of the *Water Act 2007* — Schedule 2.
