1 Name of Determination

This Determination is the *Financial Management and Accountability Act 1997 Determination 2010/16 — Section 32 (Transfer of Functions from DEWHA to DCCEE)*.

Note 1: This Determination has been made by a delegate of the Secretary of the Department of Finance and Deregulation. The Secretary is a delegate of the Minister for Finance and Deregulation in accordance with section 62 of the FMA Act. The Secretary has delegated his power in accordance with section 53 of the FMA Act.

Note 2: Acronyms and other organisational names used in this Determination are as follows:

- (a) “DEWHA” – refers to the Department of the Environment, Water, Heritage and the Arts.
- (b) “DCCEE” – refers to the Department of Climate Change and Energy Efficiency.

2 Commencement

This Determination commences on the day on which it is made.

Note: Under subsection 32(8) of the FMA Act, a Determination may be expressed to take effect before its making and registration under the *Legislative Instruments Act 2003*.

3 Amendment of Appropriation Act (No. 1) 2010-2011

Schedule 1 amends the *Appropriation Act (No. 1) 2010-2011* to transfer an amount of \$40,541,000 of the departmental item for DEWHA to the departmental item for DCCEE.

Note: The amount transferred relates to the transfer of some operations of DEWHA to DCCEE.
