Freedom of Information (Miscellaneous Provisions) Regulations² (Amendment)

Principal Regulations

- 1. In these Regulations, "Principal Regulations" means the Freedom of Information (Miscellaneous Provisions) Regulations.
- 2. Regulation 5 of the Principal Regulations is repealed and the following regulation substituted:

Responsible Minister in respect of certain authorities

"5. For the purposes of paragraph (d) of the definition of 'responsible Minister' in sub-section 4 (1) of the Act, the Minister specified in Column 3 of an item in Schedule 3 is declared to be the responsible Minister in respect of the prescribed authority specified in Column 2 of that item in that Schedule."

Schedule 1

3. Schedule 1 to the Principal Regulations is repealed and the Schedule set out in Schedule 1 to these Regulations is substituted.
