## Ombudsman Regulations<sup>2</sup> (Amendment)

### Principal Regulations

1. In these Regulations, "Principal Regulations" means the Ombudsman Regulations.

### Allowances

2. Regulation 7 of the Principal Regulations is amended by omitting paragraphs (a) and (b) and substituting the following paragraphs:

- "(a) in relation to the Ombudsman—the allowances payable to the Secretary of a Department of the Australian Public Service;
- (b) in relation to a Deputy Ombudsman—the allowances payable to a Senior Executive Service officer of the Australian Public Service."

### Schedule 1

3. Schedule 1 to the Principal Regulations is amended—

- (a) by omitting—  
"Anglo-Australian Telescope Board";
- (b) by omitting—  
"Christmas Island Phosphate Commission"; and
- (c) by inserting in its proper alphabetical position in that Schedule each of the bodies specified in Schedule 1 to these Regulations.
