Amendments of the Air Force Regulations.

1. Regulation 606 of the Air Force Regulations is amended by Private omitting paragraphs (a), (b), (c), (d), (e) and (f) from sub-regulation Use of on (1.) and inserting in their stead the following paragraphs:-

2. Regulation 607 of the Air Force Regulations is amended—

(a) by omitting from sub-regulation (i) of paragraph (b) of Private sub-regulation (1.) the figures and words "2½d. per mile "Use of, instead and inserting in their stead the figures and words "3½d. ef public convoyance. per mile"; and

(b) by omitting from sub-paragraph (ii) of that paragraph the figure and words "2d, per mile" and inserting in their stead the figure and words "3d, per mile".
