# **Excise Amendment Regulations 1998** (No. 3)<sup>2</sup>

I, WILLIAM PATRICK DEANE, Governor-General of the Commonwealth of Australia, acting with the advice of the Federal Executive Council, make the following regulations under the Excise Act 1901.

### 1. Name of regulations

1.1 These regulations are the Excise Amendment Regulations 1998 (No.3).

### 2. Commencement

2.1 These regulations commence on gazettal.

#### 3. Amendment

3.1 The *Excise Regulations 1925* are amended as set out in these regulations.

# 4. Regulation 50 (Circumstances under which refunds, rebates and remissions are made)

- 4.1 After paragraph 50 (1) (zn), insert:
  - "(zo) duty has been paid on a petroleum product that:
    - (i) is a clean fuel; and
    - (ii) falls within a classification in item 11 or 12 of the Schedule to the *Excise Tariff Act 1921*; and
    - (iii) has been packaged, after delivery into home consumption, into a package of not more than 210 litres capacity; and
    - (iv) has been sold, so packaged, for use as a solvent.".

#### 5. Regulation 176 (Exempt blended petroleum products)

5.1 Paragraph 176 (2) (h):

Omit the paragraph, substitute:

- "(h) a blend of a petroleum product on which duty has been paid at the rate specified in subparagraph 11 (H) (2) (b) or (c) of the Schedule to the *Excise Tariff Act 1921* and a product used to enhance its octane rating, except a product classified to:
  - (i) item 11 or 12 of that Schedule; or
  - (ii) if the product is imported heading 2707, 2709, 2710 or 2902 of Schedule 3 to the *Customs Tariff* Act 1995;".

5.2 Paragraph 176 (2) (i):

After "prepared additives", insert ", packaged into a package of not more than 10 litres capacity,".
