#### 4      Government business enterprises (Act, s 5)

For the definition of **GBE** in section 5 of the Act, the following authorities and companies are prescribed:

- (a) ADI Limited;
- (b) Australian Postal Corporation;
- (c) Australian Rail Track Corporation Limited;
- (d) Australian Technology Group Limited;
- (e) Defence Housing Authority;
- (f) Employment National Limited;
- (g) Essendon Airport Limited;
- (h) Health Services Australia Limited;
- (i) Medibank Private Limited;
- (j) Snowy Mountains Hydro-electric Authority;
- (k) Sydney Airports Corporation Limited;
- (l) Telstra Corporation Limited.

#### 4A      Responsible Minister (Act, s 5)

For subparagraph (b) (i) of the definition of **responsible Minister** in section 5 of the Act, the Minister for Finance and Administration is prescribed as the Minister responsible for:

- (a) Essendon Airport Limited; and
- (b) Sydney Airports Corporation Limited.
