4A Responsible Minister for Commonwealth companies (Act s 5)

For subparagraph (b) (i) of the definition of **responsible Minister** in section 5 of the Act, the Minister for Finance and Administration is prescribed as the Minister responsible for the following Commonwealth companies:

- (a) ComLand Limited;
- (b) Employment National Limited;
- (c) Essendon Airport Limited;
- (d) Sydney Airports Corporation Limited.
