#### 1 Name of Regulations

These Regulations are the Primary Industries Levies, Charges and Collection Regulations (Repeal) 1999.

#### 2 Commencement

These Regulations commence, or are taken to have commenced, as follows:

- (a) on 1 July 1999 regulations 1 to 4 and Schedule 1;
- (b) on 1 January 2000 Schedule 2.

#### 3 Savings for regulations repealed by Schedule 1

Despite the repeal of regulations by Schedule 1 to these Regulations, those regulations (as in force immediately before the commencement of Schedule 1) continue to have effect in relation to levies and charges imposed before the commencement of Schedule 1.

#### 4 Savings for regulations repealed by Schedule 2

Despite the repeal of regulations by Schedule 2 to these Regulations, those regulations (as in force immediately before the commencement of Schedule 2) continue to have effect in relation to levies and charges imposed before the commencement of Schedule 2.
