Primary Industries Levies, Charges and Collection (Horticultural Products) Repeal Regulations 2000

1 Name of Regulations

These Regulations are the Primary Industries Levies, Charges and Collection (Horticultural Products) Repeal Regulations 2000.

2 Commencement

These Regulations commence, or are taken to have commenced, as follows:

- (a) on 1 January 2000 regulations 1 to 4, and Schedule 1;
- (b) on 1 October 2000 regulations 5 and 6, and Schedule 2;
- (c) on 1 January 2001 regulations 7 and 8, and Schedule 3.

3 Repeal of Statutory Rules — Schedule 1

The Statutory Rules mentioned in Schedule 1 are repealed.

4 Savings — regulations repealed by regulation 3

Despite the repeal of regulations by regulation 3, those regulations (as in force or having effect immediately before the commencement of regulation 3) continue to have effect in relation to:

- (a) levies and charges imposed before the commencement of Schedule 1; and
- (b) exemptions from the obligation to lodge monthly or quarterly returns granted before the commencement of Schedule 1.
