**1 Name of Regulations**

These Regulations are the *Primary Industries Levies, Charges and Collection (Laying Chicken and Meat Chicken) Repeal Regulations 2000*.

**2 Commencement**

These Regulations commence on 1 January 2001.

**3 Repeal of Statutory Rules**

The Statutory Rules mentioned in Schedule 1 are repealed.

**4 Transitional — regulations repealed by regulation 3**

Despite the repeal of regulations by regulation 3, those regulations (as in force or having effect immediately before the commencement of regulation 3) continue to have effect in relation to levies imposed before the commencement of Schedule 1.
