1 Name of Regulations

These Regulations are the *Quarantine Amendment Regulations* 2003 (No. /).

2 Commencement

These Regulations commence on 1 March 2004.

3 Amendment of *Quarantine Regulations 2000*

Schedule 1 amends the Quarantine Regulations 2000.
