1 Name of Regulations

These Regulations are the *Occupational Health and Safety (Commonwealth Employment) (National Standards) Amendment Regulations 2005 (No. 1)*.

2 Commencement

These Regulations commence on the day after they are registered.

3 Amendment of *Occupational Health and Safety (Commonwealth Employment) (National Standards) Regulations 1994*
