## VARIATION TO LICENCE AREA PLAN FOR BRISBANE ANALOG TELEVISION – No 1 of 2005

Pursuant to subsection 26(2) of the *Broadcasting Services Act 1992*, the Australian Broadcasting Authority varies the Licence Area Plan for Brisbane Analog Television determined on 21 November 2002 (the principal instrument) in the manner set out below:

- (1) The determination in the principal instrument is varied to:
  - (a) number each of the paragraphs in the determination consecutively as clauses (1), (2), (3), (4), (5), (6) and (7); and
  - (b) insert the following clause after clause (7):

*“(8) A reference in this determination to a schedule or an attachment includes a reference to a schedule or attachment as amended from time to time”.*
- (2) Page 4 of the principal instrument is omitted
- (3) Schedule One to the principal instrument is deleted and substituted with the table headed Schedule One in item 2 on page 6 of this instrument.
- (4) Attachments to the principal instrument are varied to:
  - (a) omit Attachment 5.6 and to substitute Attachment 5.6 of this instrument;
  - (b) omit Attachment 6.1 and to substitute Attachment 6.1 of this instrument;
