## INTERPRETATION (AMENDMENT) ORDINANCE 1977

- 1. This Ordinance may be cited as the Interpretation (Amend-Short title. ment) Ordinance 1977.\*
- 2. In this Ordinance, "Principal Ordinance" means the Inter- Principal pretation Ordinance 1955.†

- 3. Section 5 of the Principal Ordinance is amended—
  - (a) by inserting in sub-section (1), after the definition of "District Judge", the following definition:-

"'Gazette' means-

- (a) the Commonwealth of Australia Gazette, published before or after the period that commenced on 1 July 1973 and ended on 30 June 1977;
- (b) the Australian Government Gazette published during that period; or
- (c) the Government Gazette of the Territory;";
- (b) by omitting from sub-section (1) the definition of "the Gazette".

- 4. Section 10 of the Principal Ordinance is amended—
  - (a) by omitting the words ", the Australian Government certain Gazette or the Government Gazette of the Territory" matters. and substituting the words "or the Australian Government Gazetie";
