1 Name of Regulations

These Regulations are the *Commonwealth Authorities and Companies Amendment Regulations 2006 (No. 2)*.

2 Commencement

These Regulations commence as follows:

- (a) on the day after they are registered — regulations 1 to 3 and Schedule 1;
- (b) on the day declared to be the designated day under section 3 of the *Telstra (Transition to Full Private Ownership) Act 2005* — regulation 4 and Schedule 2;
- (c) on the day on which Schedule 1 to the *Defence Housing Authority Amendment Act 2006* commences — regulation 5 and Schedule 3.
