

EXPLANATORY STATEMENT

Tariff Concession Revocation Instruments HS2007/1A to HS2007/735A

Customs Act 1901

Background

Part XVA of the *Customs Act 1901* (the Act) sets out a scheme under which Tariff Concession Orders (TCOs) may be made and revoked by the Chief Executive Officer of Customs (the CEO). A lower rate of Customs duty applies to goods that are the subject of a TCO.

Under sections 269P of the Act, a TCO will be made if the CEO is satisfied that the application for the TCO meets the core criteria, that is, on the day on which the application was lodged, no substitutable goods were produced in Australia in the ordinary course of business.

Subsection 269SD(2) of the Act provides that if, because of an amendment of the *Customs Tariff Act 1995*, the CEO is satisfied that the tariff classification that is stated in a TCO to apply to the goods the subject of the TCO has not, with effect from a particular day, applied to those goods, the CEO must:

- make an order revoking the TCO with effect from that day; and
- make a new TCO in respect of the goods with effect from the revocation.

Instruments

Tariff Concession Revocation Instruments numbered HS2007/1A to HS2007/735A were made on 20 June 2007. These instruments revoke TCOs for certain tariff classifications and make new TCOs for other tariff classifications in their place, in accordance with the attached Table. The instruments reflect changes to the *Customs Tariff Act 1995* made by the *Customs Tariff Amendment (2007 Harmonized System Changes) Act 2006* which applies to goods imported into Australia on or after 1 January 2007 and to goods imported into Australia before 1 January 2007 where the time for working out the rate of import duty on those goods had not occurred before 1 January 2007.

Consultation

No consultation was undertaken since the changes are minor or machinery in nature and do not substantially alter existing arrangements.

Commencement

Subsection 269SD(2) of the Act provides that the order revoking the TCO has effect from the day that the CEO is satisfied that the tariff classification stated to apply to the goods the subject of the TCO does not apply to those goods. Further, the new TCO has effect from that day. Tariff Concession Revocation Instruments numbered HS2007/1A to HS2007/735A revoke the TCOs specified in the attached Table with effect from 1 January 2007 and make in their place new TCOs as specified in the Table with effect from the same date.

Subsection 269SD(6) of the Act provides that section 269SD has effect despite section 12 of the *Legislative Instrument Act 2003* which limits the effect of a legislative instrument which takes effect before the date that the instrument is registered.
