



## REMUNERATION TRIBUNAL

### Determination 2007/16: Official Travel by Office Holders

- (i) Pursuant to subsections 5(2A), 7(3) and 7(4) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to various public office holders and offices in the Principal Executive Office (PEO) structure, and other matters significantly related thereto, and determines as set out below.
- (ii) This determination takes effect on and from 3 September 2007.

#### **PART 1 – TRAVEL ALLOWANCE – OFFICE HOLDERS**

- 1.1 In this part, Determination Number 3 of 2004 (as amended) is referred to as the Principal Determination.
