1 Name of Regulations

These Regulations are the Life Insurance Amendment Regulations 2007 (No. 1).

2 Commencement

These Regulations commence as follows:

- (a) on the commencement of the *Financial Sector Legislation Amendment (Simplifying Regulation and Review) Act 2007* — regulations 1 to 3 and Schedule 1;
- (b) on 1 January 2008 Schedule 2.
