1 Name of Regulations

These Regulations are the *Veterans' Entitlements (DFISA-like Payment) Amendment Regulations 2008 (No. 1)*.

2 Commencement

These Regulations commence on the day after they are registered.

3 Amendment of *Veterans' Entitlements (DFISA-like Payment) Regulations 2005*

Schedule 1 amends the *Veterans' Entitlements (DFISA-like Payment) Regulations 2005*.

Equine Workers Hardship Wage Supplement Payment means a payment, made under the guidelines known as 'Australian Government Guidelines for Ex-Gratia Equine Workers Hardship Wage Supplement Payment', as in force on 7 September 2007, administered by the Department of Families, Housing, Community Services and Indigenous Affairs.

[2] Regulation 4, definition of *primary payment*, paragraphs (e), (f) and (g)

- (d) Equine Workers Hardship Wage Supplement Payment; or
- (e) Exceptional Circumstances Relief Payment; or
- (f) Farm Help Income Support; or
- (g) Interim Income Support.

[5] Schedule 1, Part 2, clause 1, definition of *daily provisional payment rate*, subparagraph (b) (iii)
