**1 Name of Regulations**

These Regulations are the *Financial Management and Accountability Amendment Regulations 2008 (No. 3)*.

**2 Commencement**

These Regulations commence as follows:

- (a) on the day after they are registered—regulations 1 to 3 and Schedule 1;
- (b) on the commencement of Schedule 1 to the *Fisheries Legislation Amendment (New Governance Arrangements for the Australian Fisheries Management Authority and Other Matters) Act 2008*—regulation 4 and Schedule 2.
