



FMA Act Determination 2008/54 — Section 32 (Transfer of Functions from the former DEST to DIISR)

Financial Management and Accountability Act 1997

I, Tim Youngberry, Division Manager, Financial Reporting and Cash Management Division, Department of Finance and Deregulation, make this Determination under subsection 32 (2) of the *Financial Management and Accountability Act 1997* (the *FMA Act*).

This Determination is made because of changes in the administrative arrangements on 3 December 2007, specifically the abolition of the Department of Education, Science and Training, and the transfer of science, research and innovation programs to the Department of Innovation, Industry, Science and Research.

1 Name of Determination

This Determination is the *FMA Act Determination 2008/54 — Section 32 (Transfer of Functions from the former DEST to DIISR)*.

Note 1 This Determination has been made by a delegate of the Secretary of the Department of Finance and Deregulation. The Secretary is a delegate of the Minister for Finance and Deregulation: see sections 53 and 62 of the FMA Act.

Note 2 The Appropriation Acts, as made, refer to the names of particular Departments. However, some of those references have changed due to the reorganisation of government functions on 3 December 2007. The relevant changes are:

- (a) the Education, Science and Training portfolio was abolished;
- (b) the Department of Education, Science and Training was abolished;
- (c) the Resources, Energy and Tourism portfolio was established; and
- (d) the Department of Resources, Energy and Tourism was established.

Note 3 Acronyms and other organisational names used in this Determination are as follows:

- (a) “DEST” – refers to the Department of Education, Science and Training.
- (b) “DIISR” – refers to the Department of Innovation, Industry, Science and Research.

2 Commencement

This Determination is taken to have commenced on 3 December 2007.

Note Under subsection 32 (8) of the FMA Act, a Determination may be expressed to take effect before its making and registration under the *Legislative Instruments Act 2003*.

3 Amendment of *Appropriation Act (No. 1) 2004–2005*

Schedule 1 amends the *Appropriation Act (No. 1) 2004–2005* to transfer an amount of \$1,803,947.88 of the departmental item for the former Department of Education, Science and Training to the departmental item for the Department of Innovation, Industry, Science and Research.

Note The amount transferred relates to the transfer of science, research and innovation programs.
