### 1 Name of Regulations

These Regulations are the *Family Law Amendment Regulations 2008 (No. 4)*.

### 2 Commencement

- (1) These Regulations commence as follows:
  - (a) on the day after they are registered — regulations 1 to 3 and Schedule 1;
  - (b) on 30 March 2009 — Schedule 2;
  - (c) in accordance with subregulation (2) — Schedule 3.
- (2) For Schedule 3:
  - (a) if these Regulations are registered on or before the commencement of section 212 of the **Family Violence Protection Act 2008** (Vic) — Schedule 3 commences on the day after commencement of that section; or
  - (b) if these Regulations are registered after the commencement of section 212 of the **Family Violence Protection Act 2008** (Vic) — Schedule 3 commences on the day after registration.

### 3 Amendment of *Family Law Regulations 1984*

Schedules 1, 2 and 3 amend the *Family Law Regulations 1984*.
