DETERMINATION OF LEVELS OF EDUCATION 2008

- I, Deb Rollings, delegate of the Minister for Education for the purposes of subsection 7(1) of the *Schools Assistance Act 2008*, determine:
 - (i) the level of primary education, junior secondary education or senior secondary education provided at a school (other than a special school) in a State or Territory specified in Column 2 of an item in Column 1 in Schedule 1, is declared to be as set out in Column 3, Column 4 and Column 5 respectively of that item; and
 - (ii) the level of primary education or secondary education in a special school in a State or Territory specified in Column 1 in Schedule 2 is declared to be as set out in Column 2 and Column 3 respectively.
