## **1 Name of Determination**

This Determination is the *Financial Management and Accountability Determination 2009/28 – Services for other Governments and Non-agency Bodies Special Accounts Abolition 2009*.

## **2 Commencement**

This Determination will commence upon registration on the Federal Register of Legislative Instruments.

## **3 Abolition**

- (1) The Special Accounts specified in Schedule 1 are abolished.
- (2) The Special Accounts specified in Schedule 2 are abolished with effect from the time at which the balance of the appropriation for the Special Account reaches zero.

- (3) The Special Accounts specified in Schedule 3 are abolished with effect from the time at which:
- (a) a Services for Other Entities and Trust Moneys Special Account is established for the agency; and
  - (b) the balance of the appropriation for the Special Account reaches zero.
