



FMA Act Determination 2010/13 — Section 32 (Transfer of Functions from FaHCSIA to DHS)

1 Name of Determination

This Determination is the *FMA Act Determination 2010/13 — Section 32 (Transfer of Functions from FaHCSIA to DHS)*.

2 Commencement

This Determination commences on the day on which it is made.

3 Amendment of *Appropriation Act (No. 1) 2009-2010*

Schedule 1 amends the *Appropriation Act (No. 1) 2009-2010* to transfer an amount of \$11,566 of the departmental item for the Department of Families, Housing, Community Services and Indigenous Affairs to the departmental item for the Department of Human Services.

Note The amount transferred relates to the transfer of governance of the Family Assistance Office.
