1 Name of regulation

This regulation is the *Criminal Code (Terrorist Organisation—Jemaah Islamiyah) Regulation 2013*.

2 Commencement

This regulation commences on the day after it is registered.

3 Authority

This regulation is made under the Criminal Code Act 1995.

4 Schedule(s)

Each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

5 Definition

In this regulation:

Code means the Criminal Code.

6 Terrorist organisation—Jemaah Islamiyah

- (1) For paragraph (b) of the definition of *terrorist organisation* in subsection 102.1(1) of the Code, the organisation known as Jemaah Islamiyah is specified.
- (2) Jemaah Islamiyah is also known by the following names:
 - (a) Al-Jama'ah Al-Islamiyah;
 - (b) Jamaah Islamiyah;
 - (c) Jama'ah Islamiyah;
 - (d) Jemaa Islamiya;
 - (e) Jema'a Islamiya;
