1 Name of regulation

This regulation is the *Charter of the United Nations (Sanctions—Somalia) Amendment Regulation 2013 (No. 1).*

2 Commencement

This regulation commences on the day after it is registered.

3 Authority

This regulation is made under the *Charter of the United Nations Act 1945*.

4 Schedule(s)

Each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

In these Regulations, *prohibited supply to a designated person or entity* means the direct or indirect supply, sale or transfer to a designated person or entity of export sanctioned goods.
