

## CREDIT REPORTING PRIVACY CODE (CR code)

*This CR code is intended to replace the Credit Reporting Code of Conduct issued under Section 18A of the Privacy Act 1988 (this section is repealed with effect from 12 March 2014).*

*The CR code is an important part of the regulatory framework for the credit reporting system in Australia. That system is intended to increase the efficiency of Australia's consumer credit market. However, more comprehensive reporting necessitates improved privacy protections.*

*The CR code adds to aspects of the credit reporting obligations imposed by Part IIIA of the Privacy Act and the Privacy Regulation 2013. The CR code does not encompass all aspects of Part IIIA and so compliance with the CR code alone will not achieve full compliance with Part IIIA. The white rows in the table that follows are the mandatory CR code provisions. The blue rows in the table below constitute a high level summary of the provisions of Part IIIA of the Privacy Act 1988 that provide the context for the CR code obligations. Whilst the legislative summary is intended to assist readers and serve to link the CR code provisions to the legislation, the summary should not be relied upon as a comprehensive statement of the legislative obligations.*

*Bolded terms are defined in the Privacy Act 1988 or in this CR code (for ease of reading the often-used defined terms CRB, CP and individual are not bolded).*

Among other things, Part IIIA restricts the types of <b>credit information</b> that may be disclosed to <b>Credit Reporting Bodies</b> (CRBs), the circumstances in which that information may be disclosed by a CRB to <b>Credit Providers</b> (CPs) and <b>affected information recipients</b> and their handling of that disclosed information. The Privacy Act contemplates that a registered CR code will further define CRBs', CPs', and <b>affected information recipients'</b> obligations. CR code obligations are binding - a breach of the CR code is a breach of the Privacy Act. The CR code is registered and enforced by the Information Commissioner.</p>
