PAYMENT OF VISA APPLICATION CHARGES AND FEES IN FOREIGN CURRENCIES 2015 (Conversion Instrument)

(Subregulation 5.36(1A))

I, *STEVEN GROVES*, Delegate of the Minister for Immigration and Border Protection, acting under paragraph 5.36(1A)(a) of the *Migration Regulations* 1994 (the Regulations):

- 1. REVOKE Instrument number IMMI 15/001 (F2014L01712) signed on 9 December 2014, made under subregulation 5.36(1A)(a) of the Regulations; and
- 2. SPECIFY, in Schedule B to this Instrument, for the purposes of paragraph 5.36(1A)(a) of the Regulations:
 - a) in Column A:
 the foreign currency which the payment of a fee other than a visa application charge payment, must be paid; and
 - b) in Column B:
 the International Standards Organisation code (ISO Code) for the relevant currency; and
 - c) in Column C: the exchange rate for the Australian Dollar for each relevant currency.

This Instrument, IMMI 15/051, commences on 1 July 2015.
