Schedule 1—Amendments

Fuel Quality Standards Regulations 2001

1 Subregulation 3(2) (after paragraph (a) of the definition of *fuel*)

Insert:

(aa) a mixture of petrol and ethanol of which more than 50% is petrol;

2 Subregulation 3(2) (after paragraph (b) of the definition of *fuel*)

Insert:

- (ba) a mixture of automotive diesel and biodiesel (within the meaning of paragraph (g)) of which more than 50% is automotive diesel;
- 3 Subregulation 3(2) (after paragraph (g) of the definition of *fuel*)

Insert:

- (ga) a mixture of biodiesel (within the meaning of paragraph (g)) and automotive diesel of which more than 50% is biodiesel;
- 4 Subregulation 3(2) (after paragraph (h) of the definition of *fuel*)

Insert:

- (ha) a mixture of ethanol and petrol of which more than 50% is ethanol;
- 5 Subregulation 3(2) (paragraph (i) of the definition of *fuel*)
 Omit "(h)", substitute "(ha)".
- 6 Subregulation 3(2) (subparagraph (j)(i) of the definition of *fuel*)

Omit "(h)", substitute "(ha)".
