Part 1—Preliminary

1 Name

This is the *Biosecurity (First Point of Entry—Horn Island Airport) Determination 2016.*

2 Commencement

3 Authority

- (1) This instrument is made under subsection 223(1) of the *Biosecurity Act 2015*.
- (2) This instrument is made as permitted by subitem 1(1) of Schedule 3 to the *Biosecurity (Consequential Amendments and Transitional Provisions) Act 2015.*

4 Definitions

Note:

A number of expressions used in this instrument are defined in the *Biosecurity Act* 2015, including the following:

- (a) aircraft;
- (b) goods.

In this instrument:

aircraft means aircraft that are subject to biosecurity control.

goods means goods:

- (a) that are subject to biosecurity control; or
- (b) in relation to which an exposed goods order is in force.

Part 2—First point of entry

5 First point of entry—aircraft

Horn Island Airport is a first point of entry for aircraft.

6 First point of entry—goods

Horn Island Airport is a first point of entry for each of the following classes of goods:

- (a) dead fish;
- (b) personal effects as accompanied passenger baggage.

Part 3—Biosecurity entry points

Note: No areas of Horn Island Airport are designated as biosecurity entry points.

Part 4—Conditions

Note: There are no specified conditions for Horn Island Airport.

Part 5—Period of effect

7 Period of effect

This instrument has effect for 3 years beginning on the date this instrument commences.
