NOTICE OF DETERMINATION

COMMONWEALTH OF AUSTRALIA

Determination made under subclause 45D(6) of Schedule 1A to the

Higher Education Support Act 2003

As a result of the providers named in Column 2 of Schedule 1 to this Determination ceasing to be VET providers, I, Shelley Owen, a delegate of the Minister, acting under subclause 45D(6) of the *Higher Education Support Act 2003* (HESA), hereby determine that:

- (a) credits arise in the VET FEE-HELP accounts of the VET providers named in Column 2 of Schedule 2 to this Determination established by subclause 45D(1) of Schedule 1A to HESA; and
