The appointment, by Letters Patent, of a person as a Commissioner to inquire into and report on matters specified in the Letters Patent is prescribed for the purposes of paragraph 3(4)(v) of the Act.

#### 7 Staff-elected Director of the Australian Broadcasting Corporation Board

Subsection 7(11) of the Act does not apply to a person elected as the staff-elected Director in accordance with section 13A of the *Australian Broadcasting Corporation Act 1983*.
