#### **EXPLANATORY STATEMENT**

Woomera Prohibited Area Rule 2014 Determination of Exclusion Periods for Amber Zone 1 and Amber Zone 2 for Financial Year 2017 -2018 Amendment No.2

### **Purpose**

Subsection 8(1) of the *Woomera Prohibited Area Rule 2014* provides that the Minister for Defence may, by legislative instrument, determine the exclusion periods for Amber Zone 1 and Amber Zone 2 in the Woomera Prohibited Area for a financial year. The Minister has delegated the power to determine exclusion periods for a financial year.

During a financial year, exclusion periods determined by legislative instrument may be amended to vary access to zones within the Woomera Prohibited Area in accordance with subsection 33(3) of the *Acts Interpretation Act 1901*. This section provides that, where an Act confers a power to make, grant or issue any instrument of a legislative or administrative character (including rules, regulations or by-laws), the shall be construed as including a power exercisable in the like manner and subject to the like conditions (if any) to repeal, rescind, revoke, amend or vary any such instrument.

## Consultation

Consultation was not required in relation to this amendment on the basis that the determination of exclusion periods is an administrative process undertaken for each financial year.

#### Commencement

This amendment commences on the day after registration.

Woomera Prohibited Area Rule 2014 Determination of Exclusion Periods for Amber Zone 1 and Amber Zone 2 for Financial Year 2017 -2018 dated 20 March 2017 set out the dates on which holders of a permit issued under the Woomera Prohibited Area Rule 2014 are excluded from entering the Amber Zone 1 and Amber Zone 2 during financial year 2017 -2018.

This Determination was amended by *Woomera Prohibited Area Rule 2014*Determination of Exclusion Periods for Amber Zone 1 and Amber Zone 2 for

Financial Year 2017 -2018 Amendment No.1 which varied the exclusion periods for the relevant zones.

Woomera Prohibited Area Rule 2014 Determination of Exclusion Periods for Amber Zone 1 and Amber Zone 2 for Financial Year 2017 -2018 Amendment No.2 will further vary the Determination by cancelling the exclusion periods for Amber Zone 2 set out in the table below.

Exclusion Period	Zone to which the Exclusion Period applies
12 November 2017 – 18 November 2017	Amber Zone 2
19 November 2017 – 25 November 2017	Amber Zone 2
26 November 2017 – 2 December 2017	Amber Zone 2
3 December 2017 – 9 December 2017	Amber Zone 2

The cancellation of these exclusion periods will allow people to access Amber Zone 2 in accordance with their permit.

Woomera Prohibited Area Rule 2014 Determination of Exclusion Periods for Amber Zone 1 and Amber Zone 2 for Financial Year 2017 -2018 Amendment No.2

This amendment to the Determination under the *Woomera Prohibited Area Rule 2014* is compatible with the human rights and freedoms recognised or declared in the international instruments listed in section 3 of the *Human Rights (Parliamentary Scrutiny) Act 2011*.

### **Overview of the Amendment**

Woomera Prohibited Area Rule 2014 Determination of Exclusion Periods for Amber Zone 1 and Amber Zone 2 for Financial Year 2017 -2018 made under subsection 8(1) of the Woomera Prohibited Area Rule 2014 exercised the power of the Minister for Defence by her delegate to determine the exclusion periods for Amber Zone 1 and Amber Zone 2 in the Woomera Prohibited Area for the financial year 2017 -2018.

The Determination set out the dates in which holders of a permit issued under the *Woomera Prohibited Area Rule 2014* are excluded from entering the Amber Zone 1 and Amber Zone 2 during financial year 2017 -2018.

Woomera Prohibited Area Rule 2014 Determination of Exclusion Periods for Amber Zone 1 and Amber Zone 2 for Financial Year 2017 -2018 Amendment No.2 will amend the Determination by cancelling the exclusion periods set out in the table below.

Exclusion Period	Zone to which the Exclusion Period applies
12 November 2017 – 18 November 2017	Amber Zone 2
19 November 2017 – 25 November 2017	Amber Zone 2
26 November 2017 – 2 December 2017	Amber Zone 2
3 December 2017 – 9 December 2017	Amber Zone 2

## **Human rights implications**

This amendment does not engage any of the applicable rights or freedoms and is considered to have a beneficial effect as it removes restrictions on access to the Woomera Prohibited Area. Those people with a permit to access Amber Zone 2

within the Woomera Prohibited Area will no longer be subject to exclusions and restrictions on their access during the periods set out in the table above.

# Conclusion

This amendment is compatible with human rights as it does not raise any human rights issues.
